At jodichapman.com, we are committed to respecting your privacy and protecting your personally identifiable information. With your consent, we collect information that you provide (such as email addresses) in order to send periodic emails (newsletters, blogs, updates, etc.) and, if you sign up as an affiliate, we track click-throughs from your unique affiliate link so that if anyone purchases our services through your referrals, you will receive your commission. We don't sell or share your information with third parties, we make it easy for you to unsubscribe, to the best of our knowledge we comply with the General Data Protection Regulation (GDPR) and other regulations, and we make every effort to provide a safe, secure, soulful, and pleasant experience for you.

### **What personal information do we collect from the people who visit our website?**

When ordering or registering on our site, as appropriate, you may be asked to enter your email address or other details to help you with your experience.

### **When do we collect information?**

We collect information from you when you place an order or subscribe to a newsletter on our site.

### **How do we use your information?**

We may use the information we collect from you when you register, make a purchase, sign up for our newsletter, respond to a survey or marketing communication, surf the website, or use certain other site features in the following ways:

- To quickly process your transactions.
- To send periodic emails regarding your order or other products and services.

### **How do we protect visitor information?**

Our website is scanned on a regular basis and protected with sucuri.net from security holes, malware, and known vulnerabilities in order to make your visit to our site as safe as possible.

Your personal information is contained behind secured networks and is only accessible by a limited number of people who have special access rights to such systems, and are required to keep the information confidential.

We implement a variety of security measures when a user places an order enters, submits, or accesses their information to maintain the safety of your personal information.

All transactions are processed through a gateway provider and are not stored or processed on our servers.

### **Do we use “cookies”?**

Yes, but only with your knowledge and consent. Cookies are small files that a site or its service provider transfers to your computer's hard drive through your Web browser (if you allow) that enables the site's or service provider's systems to recognize your browser and capture and

remember certain information. We use them for our affiliate program: <http://www.jodichapman.com/affiliates>. IPs are tracked up to three months so if an order is placed, the person who referred them will receive a commission.

You can choose to have your computer warn you each time a cookie is being sent, or you can choose to turn off all cookies. You do this through your browser (like Internet Explorer) settings. Each browser is a little different, so look at your browser's Help menu to learn the correct way to modify your cookies.

If you disable cookies, it won't affect the user's experience and you can still place orders.

### **Stat Counter**

When someone visits [www.jodichapman.com](http://www.jodichapman.com), we use a third-party service, Stat Counter, to collect standard internet log information and details of visitor behavior patterns. We do this to find out things such as the number of visitors to the various parts of the site. This information is only processed in a way which does not identify anyone. We do not make, and do not allow Stat Counter to make, any attempt to find out the identities of those visiting our website.

### **Mailing List**

We use a third-party provider, MailChimp, to deliver our newsletter, blogs, and other email updates. We gather statistics around email opening and clicks using industry standard technologies to help us monitor and improve our services. We honor do not track signals and do not track, plant cookies, or use advertising when a Do Not Track (DNT) browser mechanism is in place.

### **California Online Privacy Protection Act (CalOPPA)**

- Honor opt-out/unsubscribe requests quickly.
- Allow users to unsubscribe by using the link at the bottom of each email.
